The Legislature

This institution appropriates the provincial budget, and makes rules or laws that citizens have to obey. The Legislature also plays an oversight role by carefully scrutinizing the activities of the Executive.

The Executive

This Arm of Government implements laws and decisions that are made by the Legislature. The Premier, who is the head of the ruling party, chooses Members of the Executive Council (MECs) from the MPLs of his/her party. Each MEC is responsible for a particular department, and takes on the title of "MEC". For instance, the Member of the Executive Council heading the Education Department is called the MEC for Education.

Byvoorbeeld, die Lid van die Uitvoerende Komitee wat die Onderwys Departement beheer, word die LUR vir Onderwys genoem.



Die Regbank

Hierdie is die derde pilaar van Regering wat verseker dat die wette wat gemaak is deur die Wetgewer handhaaf word en straf enige persoon wat dit nie handhaaf nie. Die Howe neem die mees prominente rol in die Regterlike Gesag aan.
